Data Protection Information

3. What personal data do we process?

4. Internal recipients of the personal data

In the course of the processing, the data shall be disclosed to the persons entrusted with the organisation or to members of the association, insofar as this is necessary for the fulfilment of the purpose.

5. External recipients of the personal data

Personal data will also be passed on to organisations subordinate to ISKCON Jandelsbrunn e.V. for processing within the framework of external membership administration.

6. Duration of storage / deletion

The personal data will be stored for the duration of the membership. They are deleted as soon as they are no longer required for the purpose of processing unless statutory retention periods stipulate otherwise.

In the period between the termination of membership and deletion, we restrict the processing of your personal data, e.g. by removing your address from the e-mail distribution list and restricting access authorisations.

7. Your rights

You have the following rights:

- the right of access under Article 15 of the DSGVO,
- the right to rectification according to Article 16 of the DSGVO,
- the right to erasure under Article 17 of the DSGVO,
- the right to restriction of processing according to Article 18 of the DSGVO,
- the right to data portability under Article 20 of the DSGVO,
- the right to lodge a complaint with a supervisory authority according to Article 77 of the GDPR
- the right to withdraw consent at any time without affecting the lawfulness of the processing carried out based on the consent until the withdrawal.

If you have stopped the processing of personal data with one of your claims, this may have the consequence that you can only participate in the life of the association to a limited extent or not at all.
